As a direct selling company selling the InteleTravel home-based Independent Travel Agency, PlanNet offers opportunities for Independent Representatives (IRs) to sell the travel product and/or build a business.

IRs can earn commissions and bonuses as outlined in our Compensation Plan. The following chart represents the average global earnings of the ranks of PlanNet IRs worldwide and provides high, low, and annualized averages.

The income statistics above are for all active PlanNet IRs who were enrolled during the period from January 1, 2022 to December 31, 2022. The annualized figures above represent an IR active for all 12 months.

An "Active IR" is defined as a person who enrolls with PlanNet Marketing for \$19.95 initial fee and \$19.95 monthly. During the period January 2022 to December 2022, 21.31% of all IRs earned a commission or override, while 78.69% did not. The average annual commission or override earnings of all IRs, including those who did not earn a commission or override, was \$1,015.24. The average annual commission or override earnings of that group of IRs who earned a commission or override was \$3,154.29.

All amounts are represented in U.S. dollars. The earnings of the IRs in this chart are not guarantees of the income, if any, that a PlanNet IR can or will earn through his or her participation in the Company Compensation Plan. The average IR spends between \$19.95 and \$239.40 annually in monthly administration fees as they build their business. Note that it takes hard work to make substantial income in this business. Success requires personal effort and dedication.
